The Vermont Rural Water Association is a nonprofit that supports public drinking water and wastewater systems. We promote public health and clean water through technical assistance, training, advocacy, and outreach. The organization consists of 11 staff, a Board of Directors, and a membership of over 300 of Vermont's drinking water and wastewater systems.



From the Executive Director

Although 2019 was my first year as Executive Director, it was still a successful year for Vermont Rural Water. With two new staff members and a newborn member of the VRWA family (my son Elijah), we continue to grow and strive to provide more services to our members.

While training and technical assistance remain our focus, we have expanded our advocacy and outreach work. In the fall we officially kicked off a registered apprenticeship program to train new water and wastewater operators. And since Act 21, regulating PFAS compounds, passed in the spring, we've worked hard to assist those affected by contamination. I've spent time advocating at both the state and federal levels for the needs and opinions of water and wastewater systems on PFAS and other important issues. I'm not saying there weren't a few struggles with the process, but we ended the year 2019 positioned as well if not better than 2018.

Our financial situation is strong; our staff is dedicated, talented and motivated; your board of directors is very engaged; and our members are committed.


